



## **Household Sector Balance Sheet**

## Fourth Quarter 2022

Household net worth, which is defined as assets less liabilities, grew by 6.7 per cent on a year-on-year basis in the fourth quarter 2022, at a slower pace than the preceding quarter (Table 1). Growth in assets and liabilities moderated in the fourth quarter 2022 amidst global inflation, interest rate hikes and recent government measures imposed on Singapore's property market.

Growth in assets moderated from 7.1 per cent in the third quarter to 5.9 per cent in the fourth quarter, due mainly to tepid growth in residential property assets. With a weaker growth in mortgage loans and declining level of personal loans, household liabilities grew by 0.8 per cent in the fourth quarter 2022.
