Retail Sales Index and Food & Beverage Services Index August 2025

Retail trade and food & beverage (F&B) services are integral to Singapore's domestic consumption, catering to consumers' daily needs and enjoyment. Retailers sell merchandise directly to consumers while F&B operators provide prepared food and drinks for consumption on-premises or take-away. The Retail Sales Index (RSI) and Food & Beverage Services Index (FSI) measure the performance of the retail trade and F&B services industries in Singapore respectively, based on the monthly sales of businesses (which include online sales) in these industries. The key indicators also include a snapshot of the proportion of sales conducted online.

KEN INDICATODS OF EOOD & BENEDAGE SEDVICES

OVERVIEW - RETAIL TRADE

On a year-on-year basis, retail sales rose 5.2% in August 2025, compared to the 4.6% growth in July 2025. Excluding motor vehicles, retail sales increased 4.6%, compared to the 3.9% growth in July 2025. On a seasonally adjusted basis, retail sales increased 0.5% in August 2025 over the previous month. Excluding motor vehicles, seasonally adjusted retail sales rose 1.3% compared to July 2025.

The estimated total retail sales value in August 2025 was \$4.3 billion. Of this, an estimated 13.1% were from online retail sales, compared to the 13.0% recorded in July 2025. Excluding motor vehicles, the total retail sales value was about \$3.7 billion, of which 15.3% were from online retail sales. Online retail sales made up 54.5%, 32.6% and 11.3% of the total sales of the Computer & Telecommunications Equipment, Furniture & Household Equipment and Supermarkets & Hypermarkets industries respectively.

Year-on-Year Change (at Current Prices)

Within the retail trade sector, the majority of industries recorded year-on-year sales growth in August 2025. The Watches & Jewellery industry increased 11.2%, driven mainly by higher jewellery sales. Similarly, sales of Recreational Goods and Motor Vehicles rose 9.9% and 8.9% respectively.

In contrast, Department Stores and retailers of Food & Alcohol recorded year-on-year declines in sales of 6.5% and 5.1% respectively in August 2025.

Month-on-Month Change

(at Current Prices, Seasonally Adjusted)

On a seasonally adjusted month-on-month basis, performance was mixed. Sales of Furniture & Household Equipment, Recreational Goods, as well as Wearing Apparel & Footwear rose 8.3%, 6.7%, and 5.7% respectively in August 2025.

Conversely, sales of the Department Stores and Motor Vehicles industries decreased 11.6% and 4.4% respectively in August 2025.

OVERVIEW - FOOD & BEVERAGE SERVICES

Sales of food & beverage (F&B) services declined 0.4% in August 2025 on a year-on-year basis, reversing the 1.7% growth in July 2025. On a seasonally adjusted basis, sales of F&B services fell 0.4% in August 2025 compared to the previous month.

The total sales value of F&B services in August 2025 was estimated at \$1.0 billion. Of this, an estimated 26.3% were from online sales, comparable to the 25.9% recorded in July 2025.

Year-on-Year Change (at Current Prices)

Within the F&B services sector, Restaurants registered a 3.2% sales decline in August 2025.

In contrast, turnover of Food Caterers and Fast Food Outlets rose 4.8% and 1.6% respectively. Cafes, Food Courts & Other Eating Places registered flat growth during this period.

Month-on-Month Change

(at Current Prices, Seasonally Adjusted)

On a seasonally adjusted month-on-month basis, sales of Fast Food Outlets and Food Caterers declined 2.8% in August 2025.

In contrast, turnover of Cafes, Food Courts & Other Eating Places as well as Restaurants increased 0.9% and 0.1% respectively during this period.

EXPLANATORY NOTES

Introduction

The Retail Sales Index (RSI) and Food & Beverage Services Index (FSI) measure the short-term performance of the retail trade and food & beverage (F&B) services industries based on the sales records of retail trade and F&B services establishments1 respectively. Sales figure refers to the value of retail goods or food & beverages sold to consumers during the month, excluding taxes on products such as Goods and Services Tax (GST), Additional Registration Fee (ARF) and Certificates of Entitlement (COE).

The RSI and FSI are available at current prices and in volume terms. The indices at current prices measure the changes of sales values which can result from changes in both price and quantity, while the indices in volume terms measure the changes in the volume of economic activity by removing the price effect.

Data Collection

Data used to compile the RSI and FSI are obtained primarily from the monthly surveys of retail trade and F&B services establishments. Retail trade establishments sell merchandise directly to the consumers, while F&B services establishments sell prepared food and drinks for consumption on premises or on a take-away basis.

Index Compilation

To derive the RSI and FSI at detailed industry level, the monthly sales for that industry is divided by the average monthly sales for the same industry in the reference year. The overall RSI and FSI are then computed by combining the sales indices of the detailed industries, using weights which measure each industry's relative importance in the overall retail trade and F&B services industries respectively.

To derive the indices in chained volume terms, the sales indices at current prices at detailed industry level are first deflated by the appropriate price indices. These component indices are then weighted using previous years' weights to derive the overall indices in chained volume terms. The reference year of the indices is 2017.

Online Retail and Food & Beverage Sales Proportions

The retail trade statistics cover:

- (a) (multi-channel) retailers in Singapore that sell via both physical stores and online/e-commerce sites;
- (b) retailers in Singapore that sell via physical stores only; and
- (c) retailers in Singapore that sell mainly via online/ecommerce sites.

The food & beverage services statistics cover all sales transactions of F&B establishments regardless of mode (including those transacted via food delivery platforms).

The proportion of online retail and F&B sales¹ out of the respective industry's total retail and F&B sales is estimated for the overall retail trade sector, selected retail industries and the overall food & beverage services sector.

Seasonal Adjustment

Seasonal effects are observed in both the RSI and FSI as there are usually intra-year periodic variations that repeat during the fixed period of time every year. To better reflect the underlying trend of the monthly sales, both indices are seasonally adjusted to remove the seasonal effects.

¹ Individual stalls in hawker centres, food courts, coffee shops or canteens are not covered.

² Online retail and F&B sales refer to the sales of goods where the order is received remotely and the price and terms of sale are agreed upon via online means, e.g. through company's website, third-party websites (e.g., online marketplaces, food delivery platforms), or mobile applications, regardless of how or where the goods are delivered or collected. This excludes orders made via telephone calls, facsimile, in-premise orders via kiosks or QR codes, and manually typed emails or messages. Payment may or may not be made online.
