Launch of Household Expenditure Survey 2022/23

The Singapore Department of Statistics (DOS) will conduct the 12th Household Expenditure Survey (HES) from November 2022 to November 2023. The HES is conducted once in every five years to collect information on households' consumption expenditure.

About the HES

The HES 2022/23 collects detailed information on households' expenditure and data on socio-economic characteristics as well as ownership of consumer durables.

The data collected will be used to facilitate studies on household income and expenditure patterns. The HES data are also used to update the weighting pattern and the basket of goods and services used in the compilation of the Consumer Price Index (CPI).

The HES 2022/23 covers 13,100 households, which are divided into 26 groups with each group recording their detailed daily expenditure for a period of two weeks. The first two groups of selected households will cover areas in Ang Mo Kio, Bedok South, Choa Chu Kang, Clementi, Jurong West and Serangoon. Other areas in Singapore will be covered progressively over a one-year period.

Participation from Households

Households selected for the survey will receive a notification letter from DOS, together with an information sheet on HES 2022/23. Survey officers from our Department will visit the selected households to explain the details and assist in completing the survey.

They will carry official identification cards and letters of authorisation and may visit households in the evenings. Households that wish to verify the identity of the survey officers may call the HES Hotline at 1800-888-2223*.
