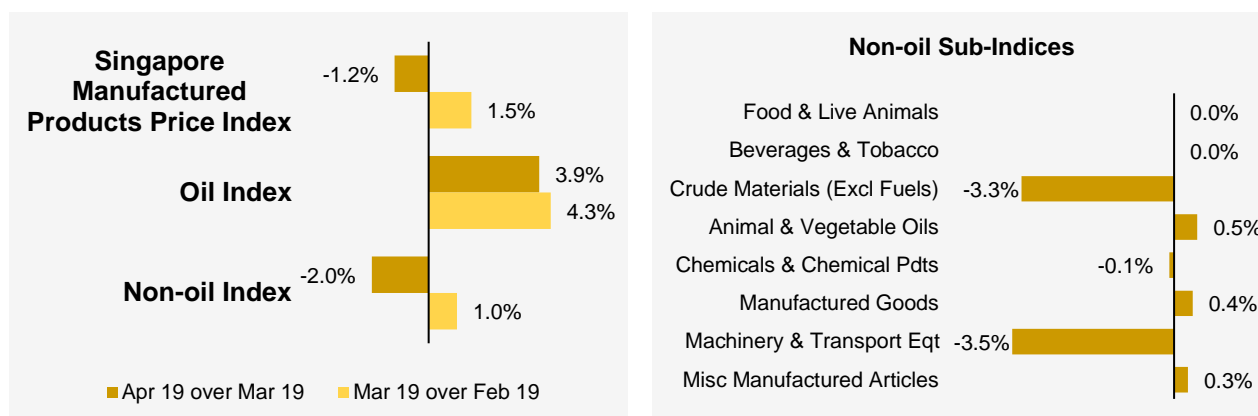

Singapore Manufactured Products Price Index (2018 = 100) April 2019

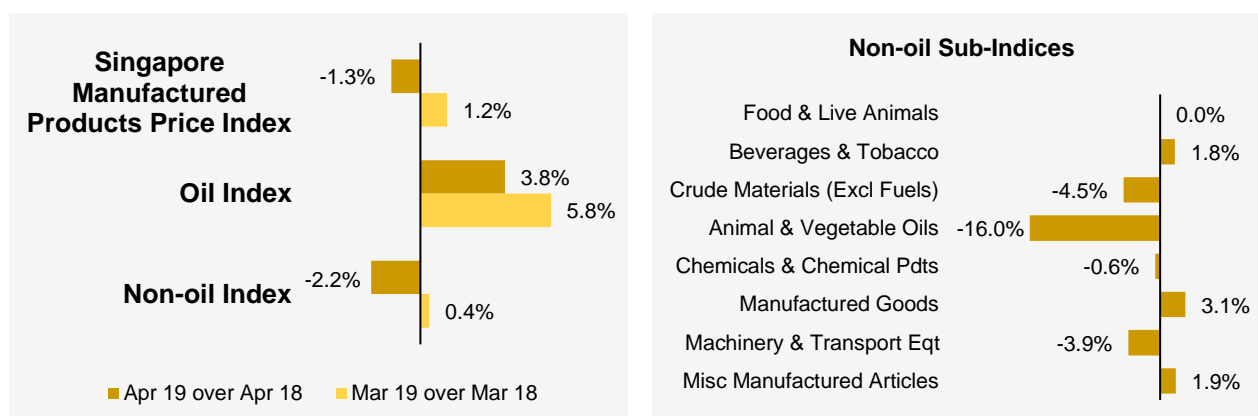
Month-on-Month Change



The Singapore Manufactured Products Price Index declined 1.2% in April 2019, in contrast to the 1.5% gain in March 2019. The Oil index increased 3.9%, extending the 4.3% gain in the previous month. The Non-oil index fell 2.0%, after rising 1.0% in March 2019.

Among the Non-oil sub-indices, decreases in the Machinery & Transport Equipment (-3.5%) index, attributed mainly to lower prices of integrated circuits, and the Chemicals & Chemical Products (-0.1%) index were partially offset by increases led by the Manufactured Goods (0.4%) and Miscellaneous Manufactured Articles (0.3%) indices.

Year-on-Year Change

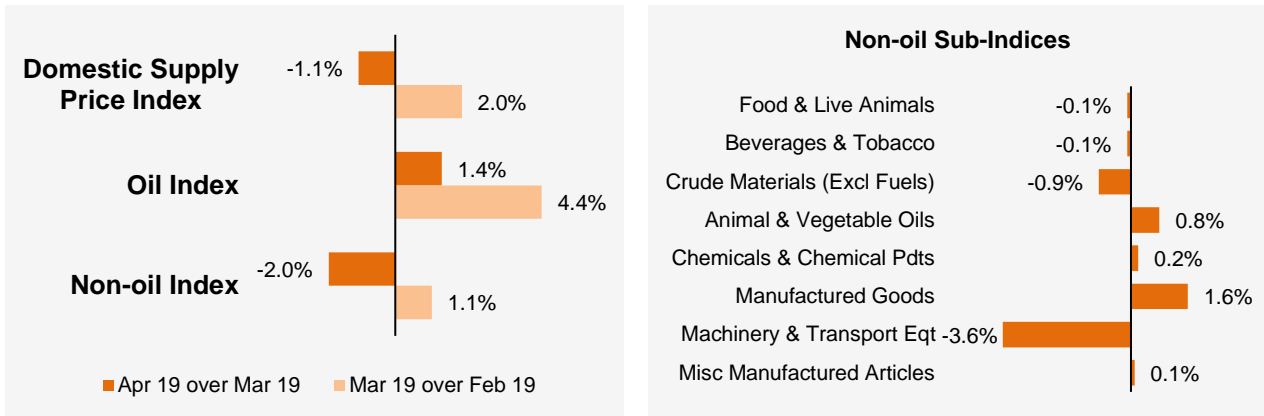


The Singapore Manufactured Products Price Index decreased 1.3% in April 2019 from a year ago, in contrast to the 1.2% gain in March 2019. The Oil index increased 3.8%, while the Non-oil index declined 2.2%.

Within the Non-oil sub-indices, decreases in the Animals & Vegetable Oils (-16.0%), Crude Materials (-4.5%), Machinery & Transport Equipment (-3.9%) and Chemicals & Chemical Products (-0.6%) indices were partially offset by increases in the Manufactured Goods (3.1%), Miscellaneous Manufactured Articles (1.9%) and Beverages & Tobacco (1.8%) indices.

Domestic Supply Price Index (2018 = 100) April 2019

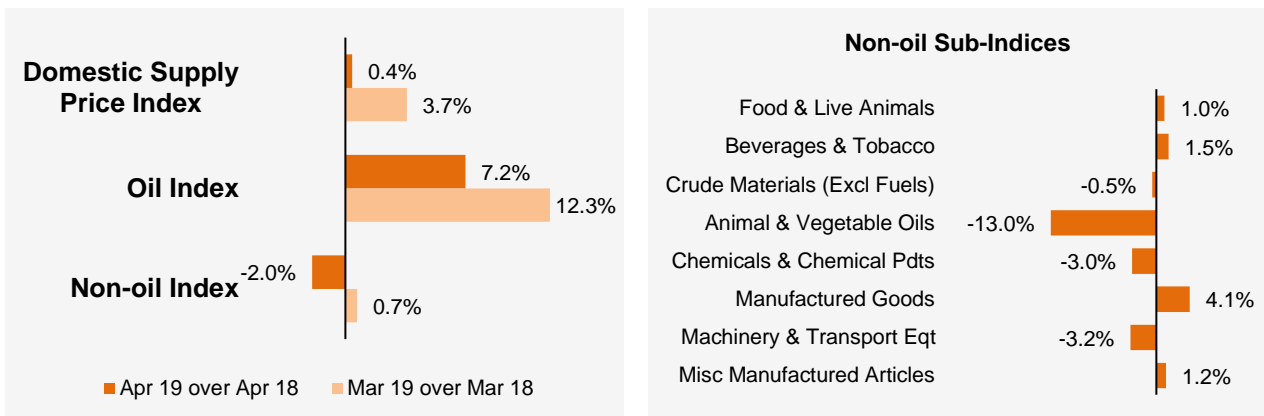
Month-on-Month Change



The Domestic Supply Price Index fell 1.1% in April 2019, after increasing 2.0% in March 2019. The Oil index increased 1.4%, extending the 4.4% gain in the previous month. The Non-oil index declined 2.0% in April 2019, in contrast to the 1.1% gain in the previous month.

For the Non-oil sub-indices, decreases were led by the Machinery & Transport Equipment (-3.6%), due mainly to lower prices of integrated circuits, and Crude Materials (-0.9%) indices. Increases led by the Manufactured Goods (1.6%) and Chemicals & Chemical Products (0.2%) indices partially moderated the declines.

Year-on-Year Change



The Domestic Supply Price Index increased 0.4% in April 2019 over the previous year, after rising 3.7% in March 2019. The Oil index rose 7.2% while the Non-oil index fell 2.0%.

For the Non-oil sub-indices, decreases in the Animal & Vegetable Oils (-13.0%), Machinery & Transport Equipment (-3.2%), Chemicals & Chemical Products (-3.0%) and Crude Materials (-0.5%) indices were partially offset by increases in the Manufactured Goods (4.1%), Beverages & Tobacco (1.5%), Miscellaneous Manufactured Articles (1.2%) and Food & Live Animals (1.0%) indices.

Technical Note

The **Singapore Manufactured Products Price Index (SMPPI)** monitors price changes of locally manufactured commodities. The weights of the index are derived from the distribution of local production by commodity in 2018. Ex-factory prices are obtained from principal manufacturers of the items concerned.

The **Domestic Supply Price Index (DSPI)** is designed to measure the changes in the price level of goods manufactured locally or imported which are retained for use in the domestic economy by the government, business or household sectors. For imported products, the prices refer to those paid by importers in bringing the goods into Singapore, commonly referred to as c.i.f. prices. In the case of Singapore manufactured products, the quotations used are ex-factory prices. The weight for each commodity item is proportional to the value of its total supply or availability in the domestic market in 2018.

Index Formula

The 2018-based series is compiled using the 'modified Laspeyres' formula where the weight reference period of 2017 preceded the price reference period of 2018. The geometric mean formula has been adopted in the computation of unweighted elementary aggregate price indices. The arithmetic mean formula is applied in compiling indices at higher levels of aggregation where weights of specific sub-indices are available.

Measurement of Changes in Price Indices

Change over previous month compares the index of the month with that of the preceding month. Such comparisons measure the change in the price index between two consecutive months. They serve as useful short-term indicators of the price movements.

Change over same period of previous year measures change in the index over a twelve-month period. Such comparisons compare the movement in the price index between similar months in two consecutive years.

Index Revision

The indices may be revised when late returns and amendments received from respondents are incorporated.

Chart 1: Index

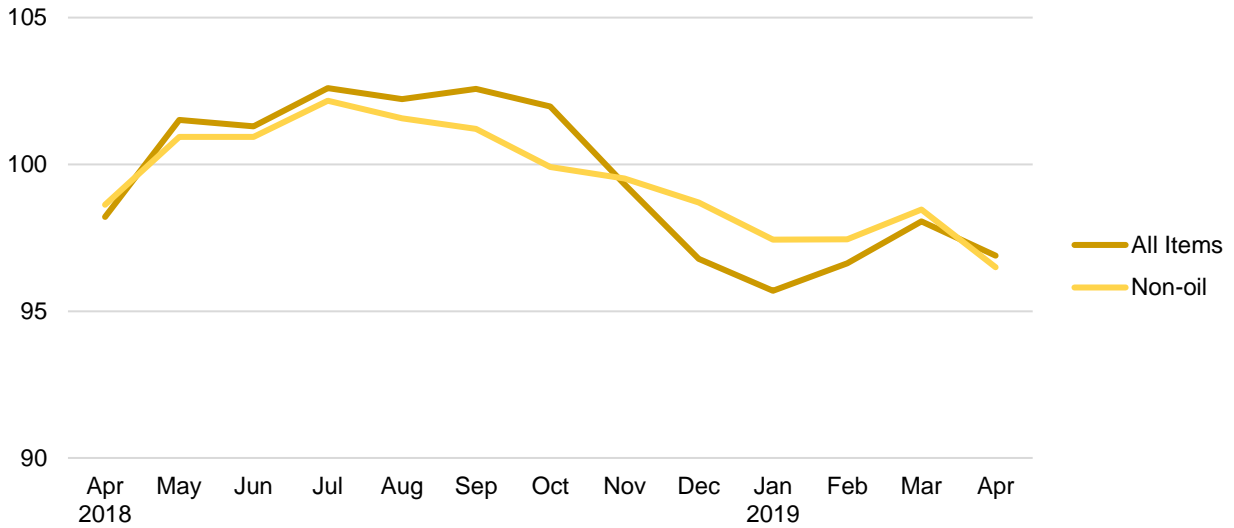


Chart 2: Month-on-Month Change

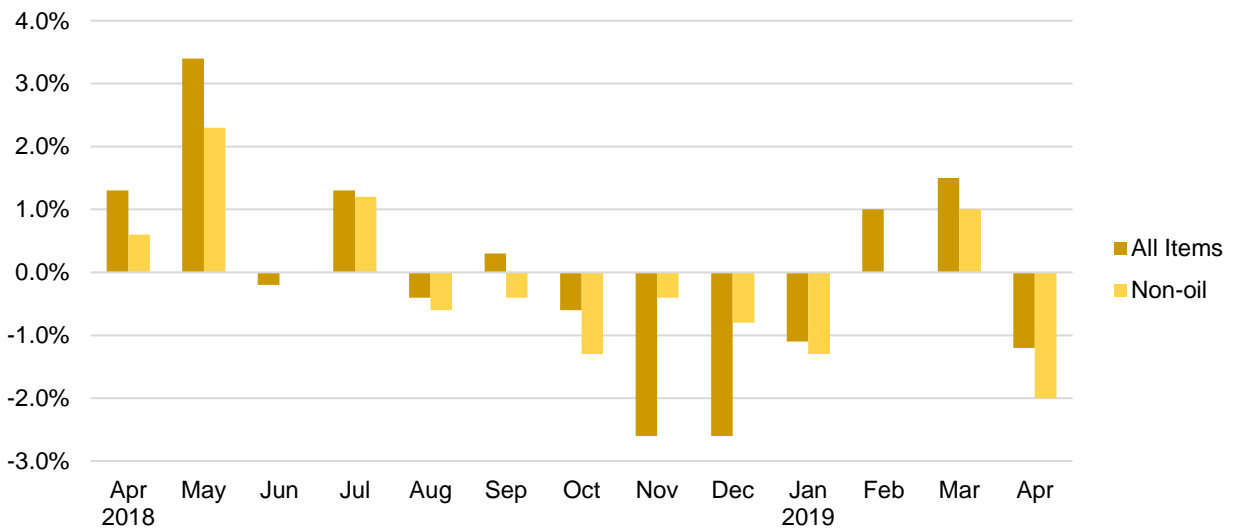
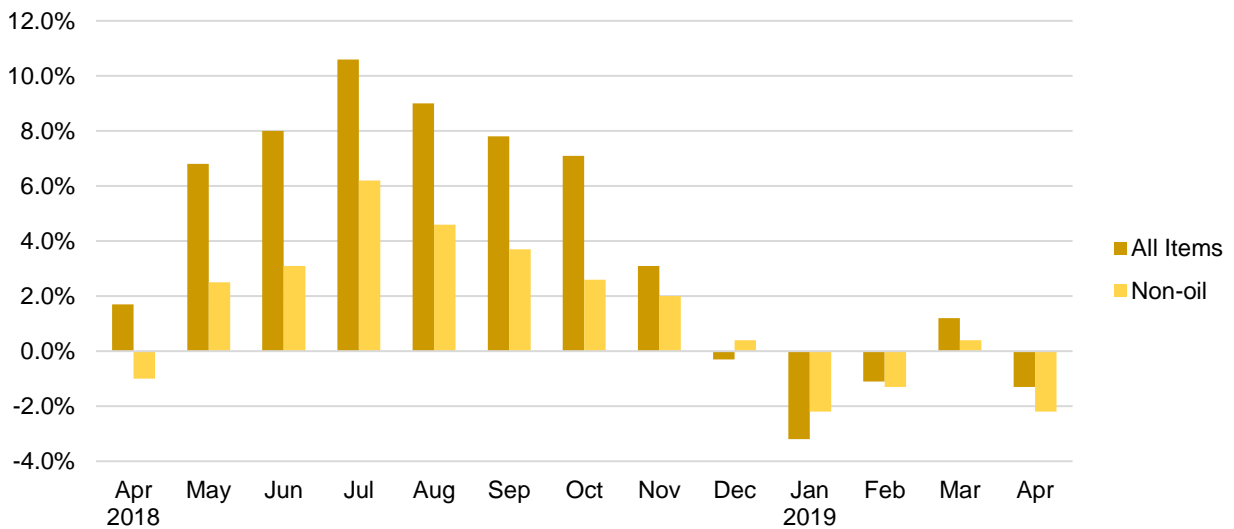


Chart 3: Year-on-Year Change

Chart 4: Index

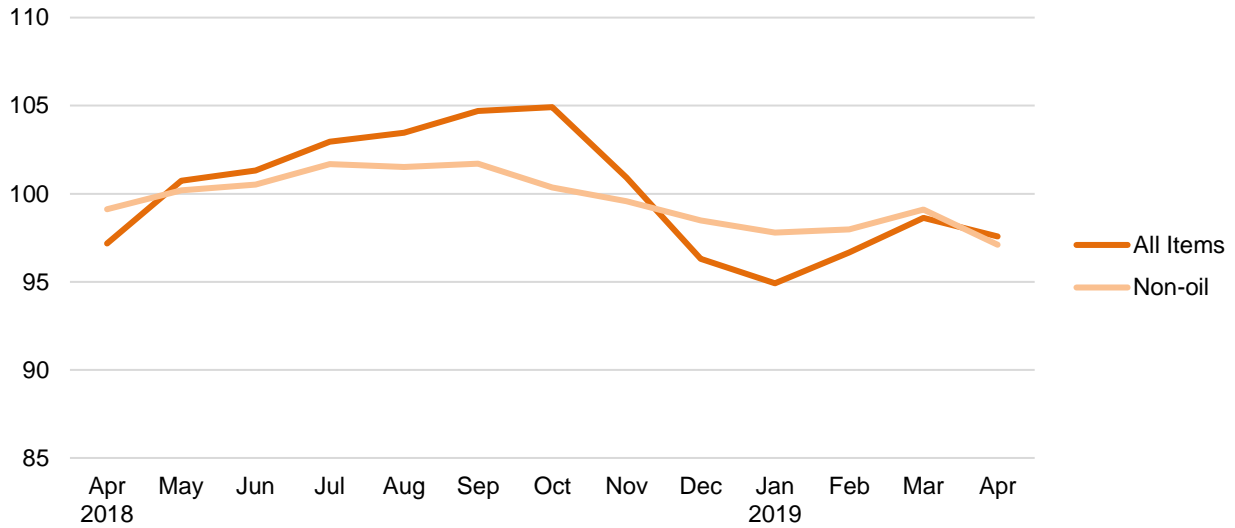


Chart 5: Month-on-Month Change

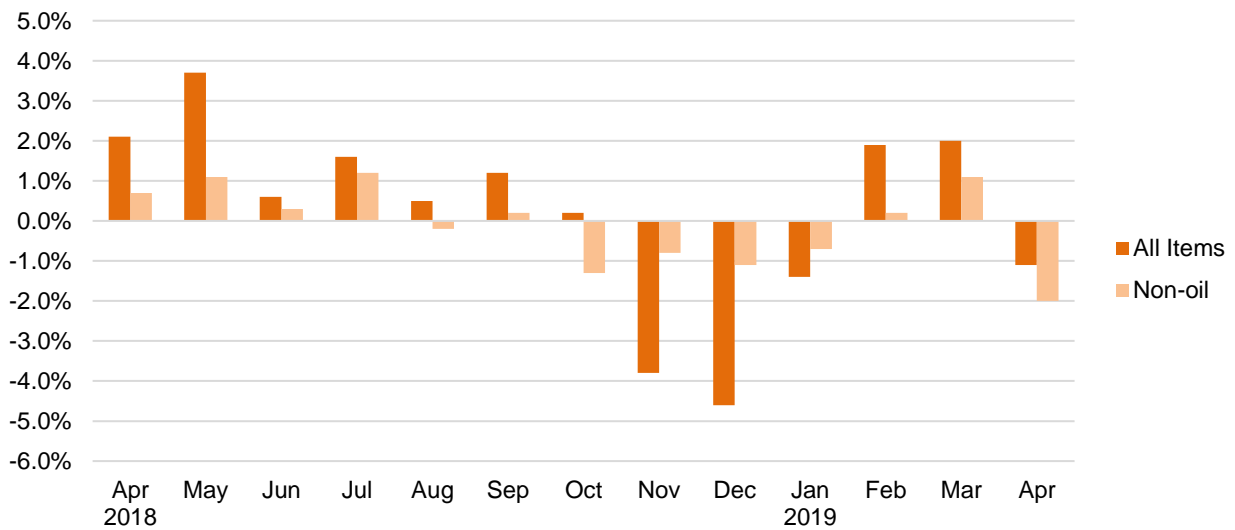


Chart 6: Year-on-Year Change

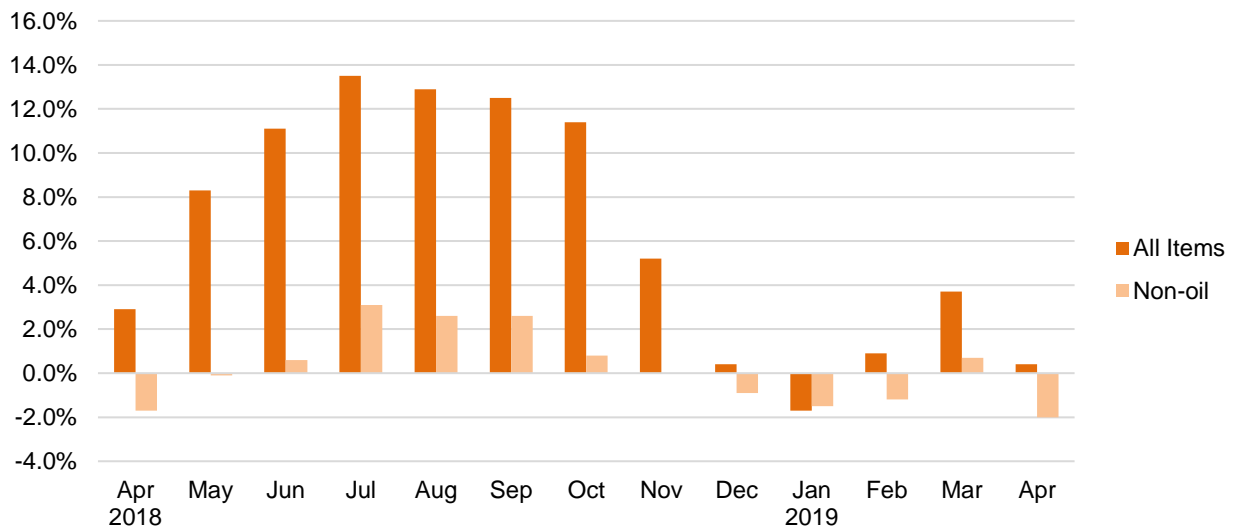
