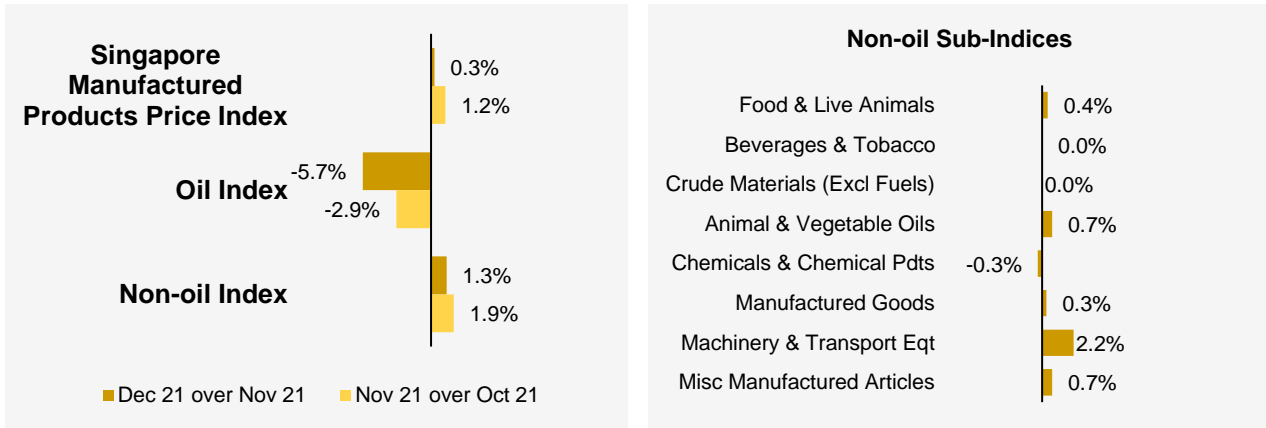

Singapore Manufactured Products Price Index (2018 = 100) December 2021

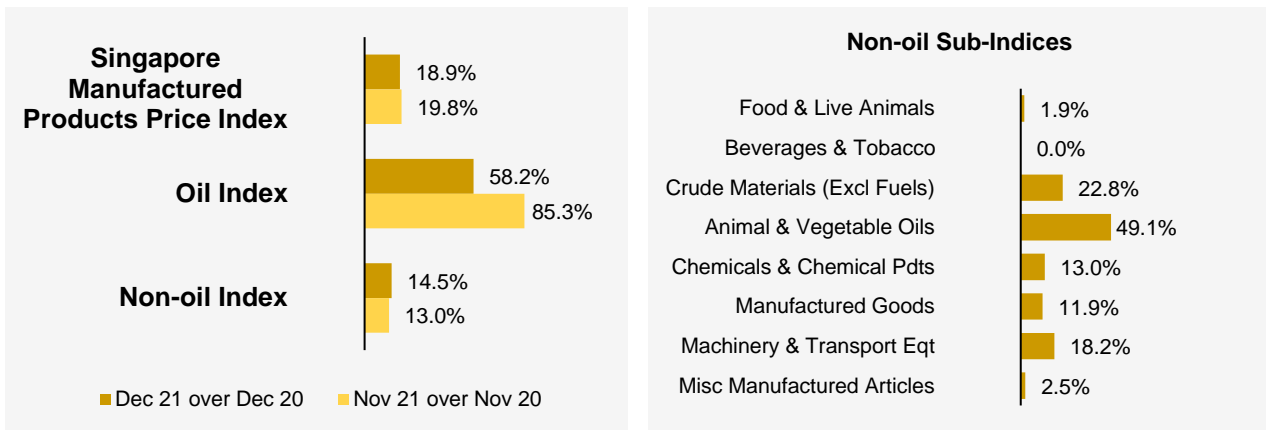
Month-on-Month Change



The Singapore Manufactured Products Price Index rose 0.3% in December 2021, following the 1.2% increase in November 2021. The Oil index fell 5.7%, extending the 2.9% drop in the previous month. The Non-oil index increased 1.3% in December 2021, following the 1.9% gain in November 2021.

Among the Non-oil sub-indices, increases were led by the Machinery & Transport Equipment (2.2%) index, due mainly to higher prices of integrated circuits, and the Miscellaneous Manufactured Articles (0.7%) index. The increases were partially moderated by the decline in the Chemicals & Chemical Products (-0.3%) index.

Year-on-Year Change



The Singapore Manufactured Products Price Index rose 18.9% in December 2021 from a year ago, extending the 19.8% gain in November 2021. The Oil and Non-oil indices increased 58.2% and 14.5% respectively.

Most of the Non-oil sub-indices rose, registering higher prices of Animal & Vegetable Oils (49.1%), Crude Materials (22.8%), Machinery & Transport Equipment (18.2%), Chemicals & Chemical Products (13.0%), Manufactured Goods (11.9%), Miscellaneous Manufactured Articles (2.5%) and Food & Live Animals (1.9%). Prices of Beverages & Tobacco were unchanged.

Annual Change

The Singapore Manufactured Products Price Index rose 9.5% in 2021 over 2020, after the 6.9% decline in 2020. Higher prices of Oil (58.7%), Animal & Vegetable Oils (39.2%), Crude Materials (15.8%), Chemicals & Chemical Products (8.1%), Manufactured Goods (6.4%), Machinery & Transport Equipment (4.3%) and Food & Live Animals (1.3%) were partially offset by lower price of Miscellaneous Manufactured Articles (-1.4%).

Domestic Supply Price Index (2018 = 100) December 2021

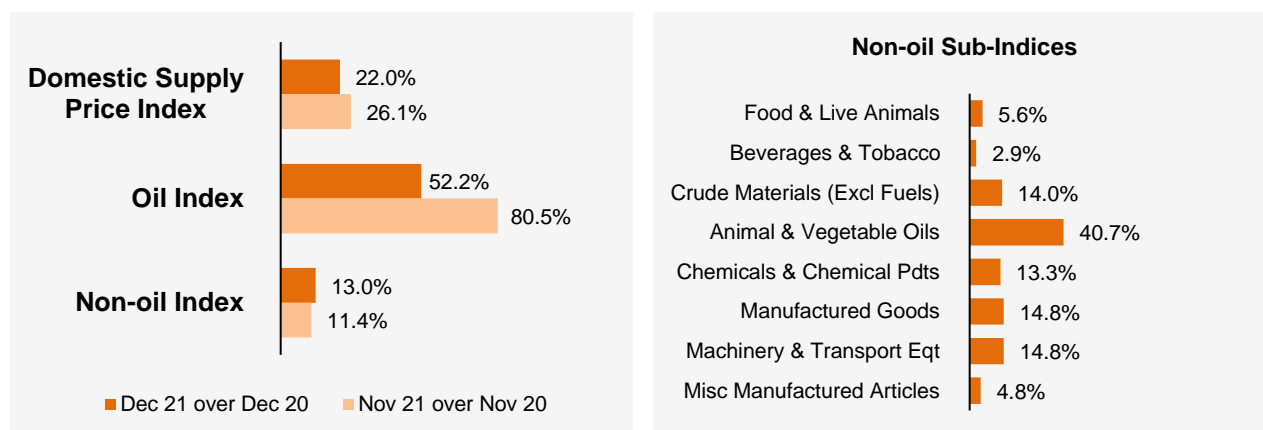
Month-on-Month Change



The Domestic Supply Price Index fell 1.1% in December 2021, extending the 0.2% decrease in the previous month. The Oil index decreased 7.2%, following the 3.8% drop in the previous month. The Non-oil index went up 1.5% in December 2021, following the 1.5% increase in November 2021.

Among the Non-oil sub-indices, increases were led by the Machinery & Transport Equipment (2.1%) and Miscellaneous Manufactured Articles (1.1%) indices, due mainly to higher prices of electrical machinery apparatus and scientific instruments respectively. The increases were partially moderated by the decline in the Animal & Vegetable Oils (-0.1%) index.

Year-on-Year Change



The Domestic Supply Price Index rose 22.0% in December 2021 from a year ago, extending the 26.1% increase in November 2021. The Oil and Non-oil indices grew by 52.2% and 13.0% respectively.

All Non-oil sub-indices rose, registering higher prices of Animal & Vegetable Oils (40.7%), Manufactured Goods (14.8%), Machinery & Transport Equipment (14.8%), Crude Materials (14.0%), Chemicals & Chemical Products (13.3%), Food & Live Animals (5.6%), Miscellaneous Manufactured Articles (4.8%) and Beverages & Tobacco (2.9%).

Annual Change

The Domestic Supply Price Index rose 15.2% in 2021 over 2020, after the 8.7% decline in 2020. Higher prices were registered for Oil (59.2%), Animal & Vegetable Oils (44.9%), Chemicals & Chemical Products (9.5%), Manufactured Goods (9.3%), Crude Materials (8.1%), Machinery & Transport Equipment (2.4%), Food & Live Animals (2.1%), Miscellaneous Manufactured Articles (0.9%) and Beverages & Tobacco (0.5%).

Technical Note

The **Singapore Manufactured Products Price Index (SMPPI)** monitors price changes of locally manufactured commodities. The weights of the index are derived from the distribution of local production by commodity in 2018. Ex-factory prices are obtained from principal manufacturers of the items concerned.

The **Domestic Supply Price Index (DSPI)** is designed to measure the changes in the price level of goods manufactured locally or imported which are retained for use in the domestic economy by the government, business or household sectors. For imported products, the prices refer to those paid by importers in bringing the goods into Singapore, commonly referred to as c.i.f. prices. In the case of Singapore manufactured products, the quotations used are ex-factory prices. The weight for each commodity item is proportional to the value of its total supply or availability in the domestic market in 2018.

Index Formula

The 2018-based series is compiled using the 'modified Laspeyres' formula where the weight reference period of 2017 preceded the price reference period of 2018. The geometric mean formula has been adopted in the computation of unweighted elementary aggregate price indices. The arithmetic mean formula is applied in compiling indices at higher levels of aggregation where weights of specific sub-indices are available.

Measurement of Changes in Price Indices

Change over previous month compares the index of the month with that of the preceding month. Such comparisons measure the change in the price index between two consecutive months. They serve as useful short-term indicators of the price movements.

Change over same period of previous year measures change in the index over a twelve-month period. Such comparisons compare the movement in the price index between similar months in two consecutive years.

Linking the Old 2012-Based Price Index Series to the New 2018-Based Price Index Series

The SMPPI and DSPI have been rebased from base year 2012 to base year 2018. To facilitate comparison of the historical price indices across base years, the old 2012-based series are linked to the new 2018-based series by re-scaling them via a Linked Coefficient. The Linked Coefficient is the ratio of the annual 2018-based index in 2018 to the annual 2012-based index in 2018.

Example : Linking the old Iron & Steel Index series for SMPPI prior to 2018, to the 2018-based Iron & Steel Index (2018=100)

1) Calculate the linked coefficient

Year	Iron & Steel Index (2012=100)	Iron & Steel Index (2018=100)	Linked Coefficient
2018	78.0	100.0	$100.0 \div 78.0 = 1.282$

2) Re-scaling the old series to the 2018-based series using the Linked Coefficient

Year	Month	Iron & Steel Index (2012=100)	Iron & Steel Index (2018=100)
2016	Dec	70.8	$70.8 \times 1.282 = 90.8$
2017	Jan	71.4	$71.4 \times 1.282 = 91.5$

Linking Method for Maintaining the Old Index Reference Period

To continue the old 2012-based index series going forward in time, re-scale the new 2018-based index series to the old base year 2012 level, via a Linked Coefficient. The Linked Coefficient is the ratio of the annual 2012-based index in 2018 to the annual 2018-based index in 2018.

Example : Linking the new 2018-based Iron & Steel Index series for SMPPI to the 2012-based Iron & Steel Index (2012=100)

1) Calculate the linked coefficient

Year	Iron & Steel Index (2018=100)	Iron & Steel Index (2012=100)	Linked Coefficient
2018	100.0	78.0	$78.0 \div 100.0 = 0.780$

2) Re-scaling the new series to the 2012-based series using the Linked Coefficient

Year	Month	Iron & Steel Index (2018=100)	Iron & Steel Index (2012=100)
2019	Jan	105.6	$105.6 \times 0.780 = 82.4$
2019	Feb	104.7	$104.7 \times 0.780 = 81.7$

Index Revision

The indices may be revised when late returns and amendments received from respondents are incorporated.

Chart 1: Index

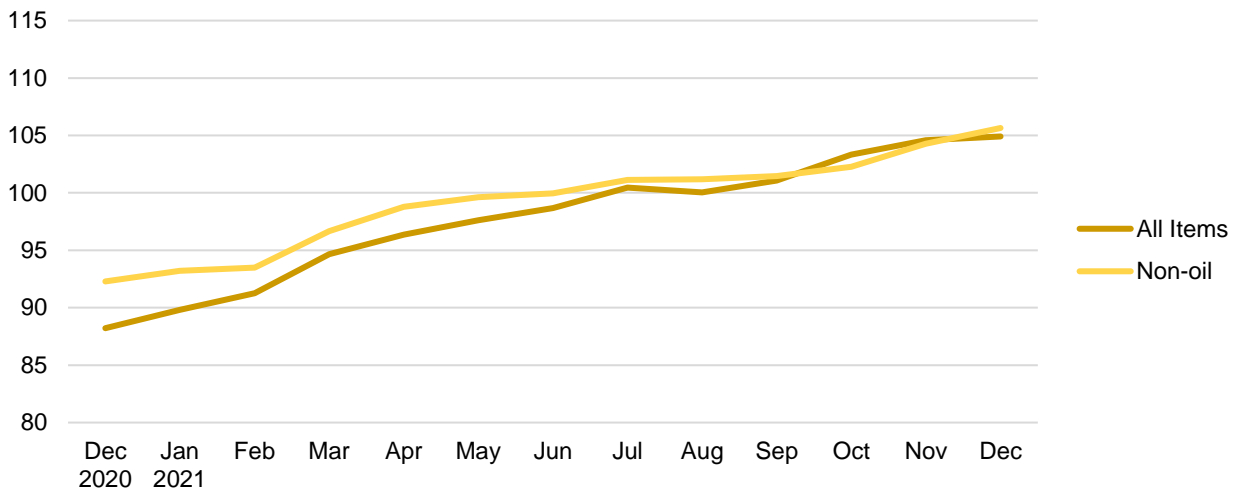


Chart 2: Month-on-Month Change

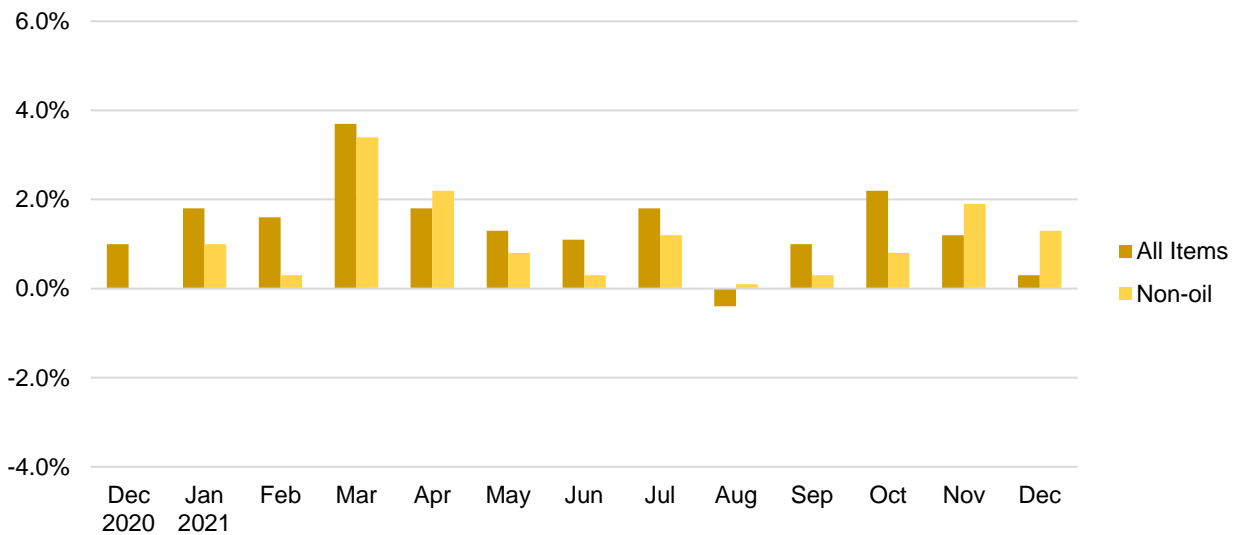
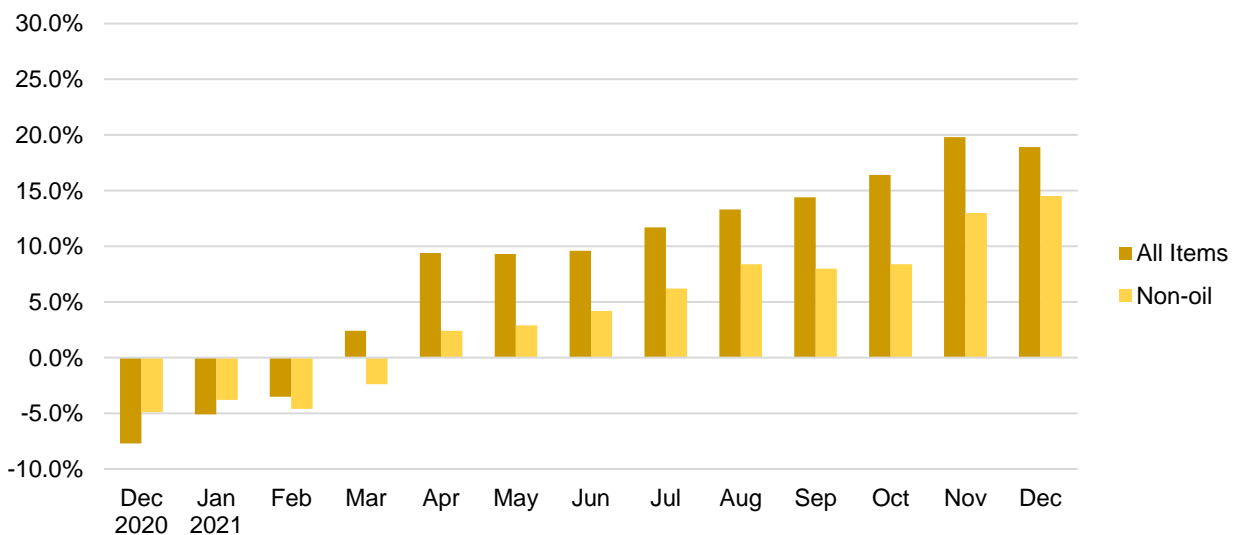


Chart 3: Year-on-Year Change

Chart 4: Index

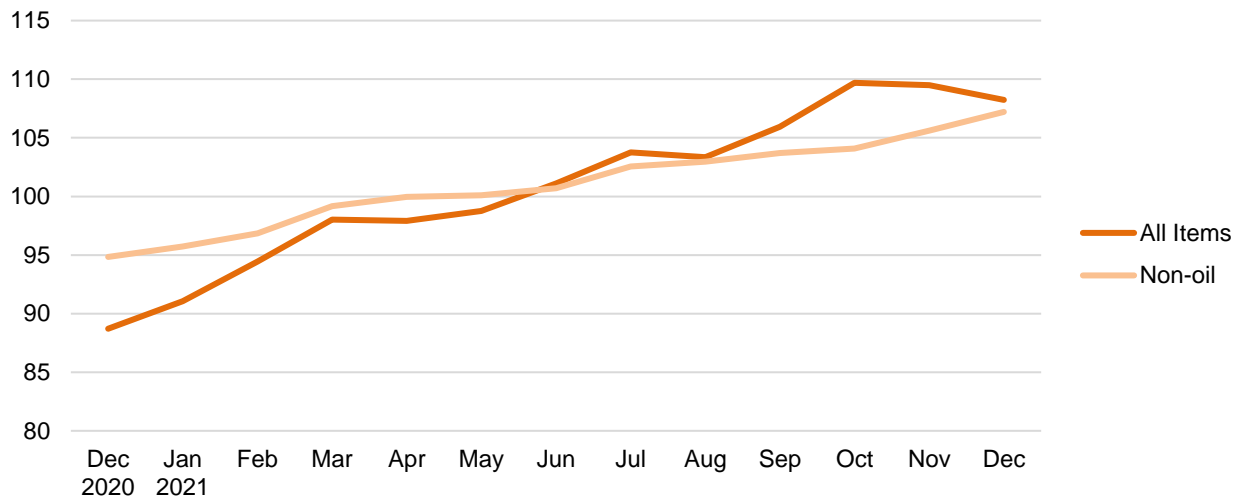


Chart 5: Month-on-Month Change

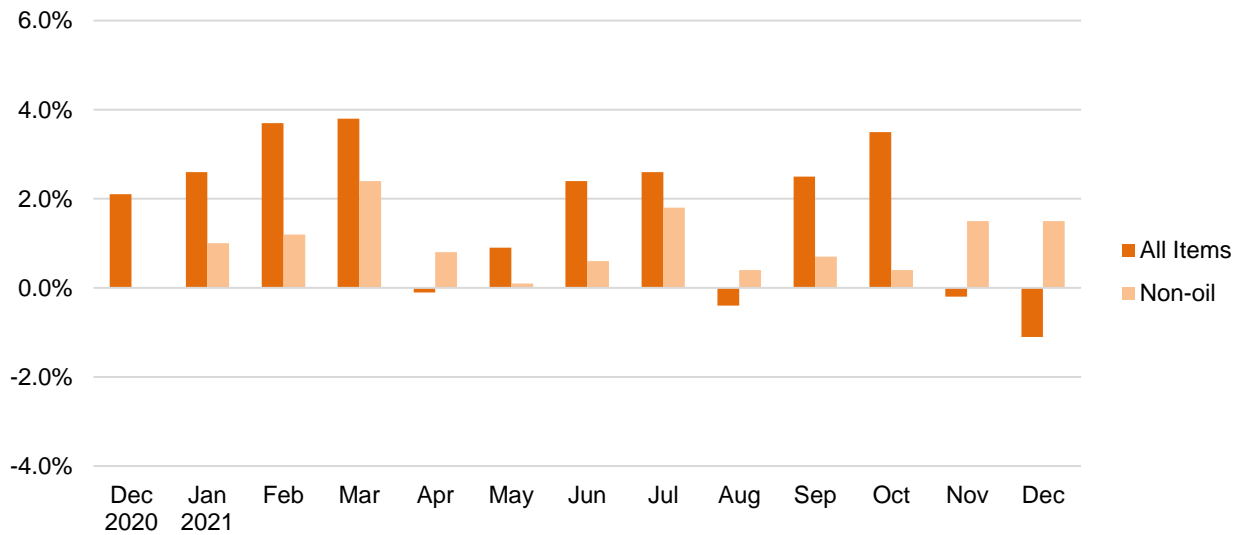


Chart 6: Year-on-Year Change

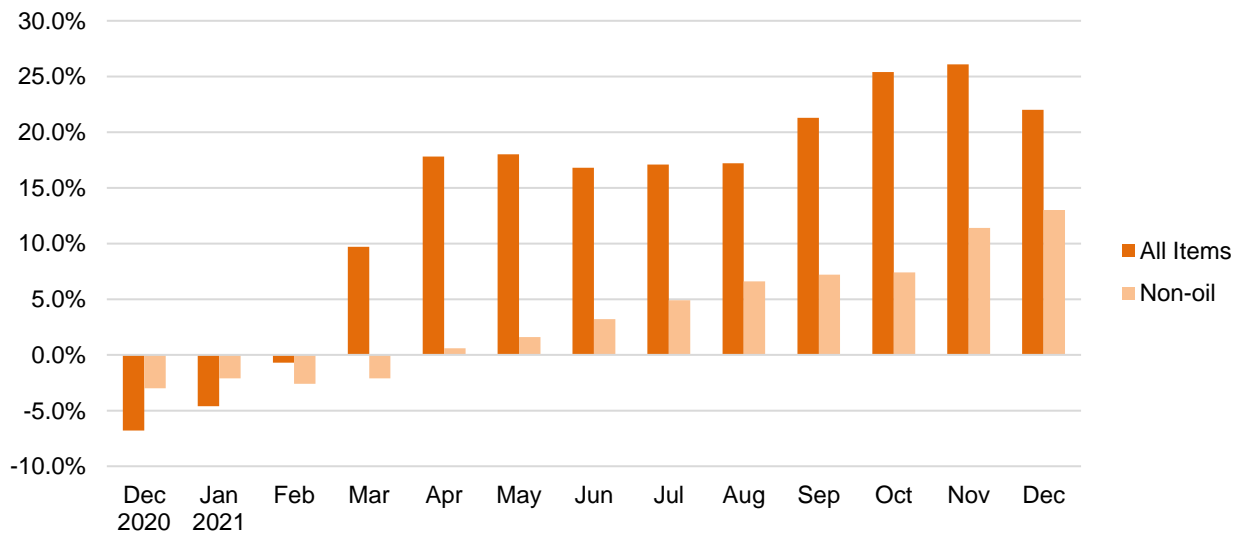
