The Department of Statistics (DOS) compiles a suite of Services Producer Price Indices (SPPIs) to measure the changes in the average prices of services produced by establishments, for selected industries of the Singapore economy. These are prices that reflect the amount received by a service producer exclusive of any taxes. The SPPIs facilitate the analysis of macro-economic conditions and in monitoring price movements of the services sector. More importantly, the SPPIs are used mainly as price deflators in the national accounts to estimate the real growth of the services sector in the Singapore economy.

#### Quarter-on-quarter

The ASPI rose 3.4 per cent in 1Q2023 over the previous quarter, rebounding strongly from 3 consecutive quarters of decline, due to a surge in charges of accounting and auditing as well as book-keeping activities.

#### Year-on-year

On a year-on-year comparison, the ASPI grew modestly by 0.1 per cent in 1Q2023, with the increase in book-keeping rates moderated by lower accounting and auditing charges.

#### **Quarter-on-quarter**

The CHPI fell 0.4 per cent in 1Q2023, reversing the 1.0 per cent increase in 4Q2022. The Container Depot Services and Stevedoring Services Price Indices declined 0.4 per cent and 0.8 per cent respectively while the Crane Services Price Index was unchanged.

#### Year-on-year

The CHPI gained 2.8 per cent in 1Q2023, after increasing 3.2 per cent in 4Q2022. The Stevedoring Services, Crane Services and Container Depot Services Price Indices rose 7.8 per cent, 0.8 per cent and 0.2 per cent respectively.

#### **Quarter-on-quarter**

The CISPI fell 1.8 per cent in 1Q2023 over the last quarter. Both the Computer Programming & Consultancy Price Index and the Information Services & Online Marketplace Price Index declined 2.5 per cent and 0.6 per cent respectively.

#### Year-on-year

On a year-on-year basis, the CISPI fell 0.4 per cent in 1Q2023, due mainly to lower charges of computer programming and consultancy services. The Computer Programming & Consultancy Price Index declined 0.9 per cent, which was partially offset by the 0.3 per cent increase in the Information Services & Online Marketplace Price Index.

#### Quarter-on-quarter

The FFPI fell 7.0 per cent in 1Q2023, extending the 8.2 per cent decline in 4Q2022, attributed to lower sea and air freight forwarding prices. The Sea and Air Freight Forwarding Price Indices dipped 9.8 per cent and 6.7 per cent respectively, while the Land Freight Forwarding Price Index climbed 20.7 per cent in 1Q2023.

#### Year-on-year

In comparison to 1Q2022, the FFPI fell 14.0 per cent in 1Q2023, attributed mainly to lower sea freight forwarding charges. The Sea and Air Freight Forwarding Price Indices fell 21.9 per cent and 8.2 per cent respectively, while the Land Freight Forwarding Price Index increased by 41.8 per cent.

#### Quarter-on-quarter

The SFTPI fell 13.9 per cent in 1Q2023, extending the 8.3 per cent decline in 4Q2022. This was caused by lower freight rates across the freight water transport industry as the Containerised Freight Transport, Dry Bulk Freight Transport, and Liquid Bulk & Gas Freight Transport Price Indices fell 19.7 per cent, 16.0 per cent and 7.4 percent respectively.

#### Year-on-year

On a year-on-year comparison, the SFTPI dropped 15.8 per cent in 1Q2023, continuing the 6.8 per cent decline in 4Q2022, due mainly to lower freight charges for the Containerised Freight Transport and Dry Bulk Freight Transport Price Indices which fell 47.5 per cent and 21.2 per cent respectively.

#### **Quarter-on-quarter**

The TSPI rose 0.1 per cent in 1Q2023, continuing the 1.8 per cent growth in 4Q2022. This was attributed to higher charges of internet access services and other telecommunication services.

#### Year-on-year

On a year-on-year basis, the TSPI gained 3.0 per cent in 1Q2023, extending the 3.2 per cent rise in 4Q2022. The Internet Access Providers & Others Price Index increased 5.0 per cent, while the Wired & Wireless Services Price Index was unchanged.

#### **Quarter-on-quarter**

The WSPI rose 1.1 per cent in 1Q2023, continuing the 0.6 per cent in 4Q2022. This increase was driven by gains in the Dangerous Goods Storage and General & Refrigerated Warehousing Price Indices, which rose 1.4 per cent and 0.8 per cent respectively.

#### Year-on-year

As compared to 1Q2022, the WSPI grew by 2.6 per cent in 1Q2023. This was due to increases in the General & Refrigerated Warehousing and Dangerous Goods Storage Price Indices, which climbed 3.7 per cent and 1.3 per cent respectively.

#### REBASING OF SERVICES PRODUCER PRICE INDICES

The Singapore Department of Statistics (DOS) has rebased the following SPPIs to base year 2022.

Services Producer Price Index	Previous Base Year
Accounting Services Price Index	2017
Freight Forwarding Price Index	2017

The rebasing exercise is conducted periodically to ensure that the coverage of service products and the weighting structure of the index are representative of the current activities and market share of the industry. For more information on the rebasing exercise, please refer to the respective information papers on SingStat Website.

#### **EXPLANATORY NOTES**

The Services Producer Price Indices (SPPIs) cover key priority services sectors that require price deflators to obtain more precise and reliable measurement of real national accounts estimates.

The SPPIs are compiled from prices collected from routine statutory price surveys conducted by DOS under the Statistics Act 1973, or from online or administrative sources. The selection of companies for the price survey of an industry is generally based on purposive and stratified sampling methods. A representative sample of service products that can be priced over time, is selected from each company.

The SPPIs are aligned to the Singapore Standard Industrial Classification. They are calculated using the modified Laspeyres price index formula with fixed base weights<sup>1</sup>, where the weights reference period precedes the price reference period. The price indices at the higher level are aggregated from the lower level price indices together with their corresponding weights using weighted arithmetic means. Non-responses are imputed for, in accordance with IMF guidelines<sup>2</sup> and aligned with the best practices of other National Statistical Offices overseas.

The SPPIs are rebased every five years to ensure that they remain relevant to the selected industries. During the rebasing exercise, the basket of services and the weights structure of the SPPIs are updated to correspond to the prevailing production patterns of the industry. The weights are mainly obtained from surveys conducted by DOS and supplemented by administrative data. The frequency of rebasing may be shorter for service industries that are more dynamic.

The SPPIs are published quarterly. The quarters are defined as 1Q (Jan to Mar), 2Q (Apr to Jun), 3Q (Jul to Sep) and 4Q (Oct to Dec). The quarter-on-quarter change (Q-o-Q) refers to the percentage change of the reference quarter over the previous quarter e.g., 2Q2020/1Q2020. The year-on-year change (Y-o-Y) refers to the percentage change of the reference quarter over the same quarter in the previous year e.g., 2Q2020/2Q2019.
