The Department of Statistics (DOS) compiles a suite of Services Producer Price Indices (SPPIs) to measure the changes in the average prices of services produced by establishments, for selected industries of the Singapore economy. These are prices that reflect the amount received by a service producer exclusive of any taxes. The SPPIs facilitate the analysis of macro-economic conditions and monitoring of price movements in the services sector. In addition, the SPPIs are used as price deflators in national accounts to estimate the real growth of the services sector in the Singapore economy.

Quarter-on-quarter

The ASPI fell 0.7% in 1Q 2025, reversing the 0.6% gain in 4Q 2024. This was due to the higher weighted Accounting & Auditing sub-index which decreased 0.8%.

Year-on-year

On a year-on-year comparison, the ASPI gained 2.5% in 1Q 2025, continuing the increase of 6.2% in 4Q 2024. This was driven by the growth in both the Accounting & Auditing and Bookkeeping sub-indices, which increased by 2.6% and 1.0% respectively.

Quarter-on-quarter

The CHPI rose 0.3% in 1Q 2025, continuing the 0.2% increase in 4Q 2024. The rise was attributed to the increase in the Container Depot Services (1.0%) and Crane Services (0.1%) sub-indices.

Year-on-year

Compared to 1Q 2024, the CHPI fell 1.3% in 1Q 2025, matching the same rate of decline in 4Q 2024. This was attributed to the decline in the Crane Services sub-index (-4.5%), which was partially offset by the increases in the Container Depot Services (1.6%) and Stevedoring Services (0.6%) sub-indices.

Quarter-on-quarter

The CISPI rose 0.4% in 1Q 2025 over the last quarter, extending the 0.9% rise seen in 4Q 2024. This was due to higher charges for Computer Programming & Consultancy services and Information Services & Online Marketplace services.

Year-on-year

On a year-on-year basis, the CISPI grew by 2.8% in 1Q 2025, driven by the higher prices for both Computer Programming & Consultancy services and Information Services & Online Marketplace services.

Quarter-on-quarter

The FFPI declined 2.8% in 1Q 2025 compared to the previous quarter, extending the 0.9% decrease in 4Q 2024. This resulted from decreases in both the Sea Freight Forwarding (-3.0%) and Air Freight Forwarding (-3.1%) sub-indices.

Year-on-year

When compared against 1Q 2024, the FFPI increased 7.2% in 1Q 2025, moderating from the 7.7% gain in 4Q 2024. This was driven by increases in the Sea Freight Forwarding (10.5%) and Air Freight Forwarding (4.8%) sub-indices.

Quarter-on-quarter

The PCPI rose 4.0% in 1Q 2025, reversing the 0.8% decline in 4Q 2024. This was due to higher charges for both local (0.2%) and international (4.6%) postal and courier services.

Year-on-year

On a year-on-year basis, the PCPI dropped 0.6% in 1Q 2025, continuing the 2.8% decrease in 4Q 2024. This was attributed to the declines of the Local Postal & Courier (-2.5%) and International Postal & Courier (-0.3%) sub-indices.

Quarter-on-quarter

The SFTPI declined in 1Q 2025 (-7.3%), with the Dry Bulk Freight Transport sub-index recording the steepest decline (-15.6%) among the three sub-indices, followed by Liquid Bulk & Gas Freight Transport (-5.3%) and Containerised Freight Transport (-1.7%). Contributing factors to the sluggish dry bulk freight transport market included seasonal effects during the Chinese New Year period¹, which led to reduced chartering activity and higher vessel availability in key Asian trade routes.

Year-on-year

The SFTPI fell 5.6% in 1Q 2025, reversing the 10.6% increase in 4Q 2024. This decrease was attributed to declines in the Liquid Bulk & Gas Freight Transport (-18.4%) and Dry Bulk Freight Transport (-6.5%) sub-indices.

Quarter-on-quarter

The TSPI gained 0.5 per cent in 1Q 2025 over the last quarter, after dipping 0.3 per cent in 4Q 2024. This was caused by higher charges for Wired & Wireless Telecommunications Services (0.8%) and Internet Access Providers & Other Telecommunications Services (0.3%).

Year-on-year

On a year-on-year comparison, the TSPI fell 1.0% in 1Q 2025, extending the 1.1 per cent decline in 4Q 2024. This was mainly due to the decline of the Internet Access Providers & Other Telecommunications Services sub-index (- 2.8%), which was partially moderated by the increase in the Wired & Wireless Telecommunications Services sub-index (1.7%).

Quarter-on-quarter

The WSPI grew by 0.3% in 1Q 2025, continuing the 1.5% rise in 4Q 2024. This growth can be attributed to the 0.9% increase in the Dangerous Goods Storage sub-index.

Year-on-year

The WSPI continued its upward trajectory by gaining 2.9% in 1Q 2025, extending the increase of 3.9% in the previous quarter. This was due to the General & Refrigerated Warehousing and the Dangerous Goods Storage sub-indices rising 4.0% and 1.6% respectively.

EXPLANATORY NOTES

The Services Producer Price Indices (SPPIs) cover key priority services industries that require price deflators to obtain more precise and reliable measurement of real national accounts estimates.

The SPPIs are compiled from prices collected from routine statutory price surveys conducted by DOS under the Statistics Act 1973, or from online or administrative sources. The selection of companies for the price survey of an industry is generally based on purposive and stratified sampling methods. A representative sample of service products that can be priced over time is selected from each company.

The SPPIs are aligned to the Singapore Standard Industrial Classification and are compiled in accordance with IMF guidelines² in line with international best practice. They are calculated using the modified Laspeyres price index formula with fixed base weights³, where the weights reference period precedes the price reference period. The price indices at the higher level are aggregated from the lower-level price indices together with their corresponding weights using weighted arithmetic means.

The SPPIs are generally rebased every five years to ensure that they remain relevant to the selected industries. During the rebasing exercise, the basket of services and the weights structure of the SPPIs are updated to correspond to the prevailing production patterns of the industry. The weights are mainly obtained from surveys conducted by DOS and supplemented by administrative data. The frequency of rebasing may be shorter for service industries that are more dynamic.

The SPPIs are published quarterly. The quarters are defined as 1Q (Jan to Mar), 2Q (Apr to Jun), 3Q (Jul to Sep) and 4Q (Oct to Dec). The quarter-on-quarter change (Q-o-Q) refers to the percentage change of the reference quarter over the previous quarter e.g., 2Q2020/1Q2020. The year-on-year change (Y-o-Y) refers to the percentage change of the reference quarter over the same quarter in the previous year e.g., 2Q2020/2Q2019.

The published SPPIs are not seasonally adjusted. The published indices for previous reference quarters may be revised when late returns and amendments received from survey respondents are incorporated at a later date.
